

**PROCEDURES AND GUIDELINES FOR BAGGAGE ON PARIS ROUTE
EFFECTIVE 01 JULY 2009**

1. Applicable baggage allowance per passenger will be as follows:

➤ **Weight concept**

First Class (on AF aircrafts)	=	40 kg
Business Class	=	30 kg
Economy class	=	20 kg

➤ **Piece concept** (for transatlantic travel)

First Class (on AF aircrafts)	=	2 Bags of 32 kg each
Business Class	=	2 Bags of 32 kg each
Economy Class	=	2 Bags of 23 kg each

2. Infants less than 2 years will benefit from a free baggage allowance of 10 kg and in addition, free transport of their prams as well as one piece of cabin luggage.

3. Excess baggage will be charged as follows:

➤ Mauritius-Paris or vv.	-	EUR 15 per kg
➤ Mauritius-Paris-Europe	-	EUR 15 per kg
➤ Europe-Paris-Mauritius	-	EUR 15 per kg

4. For piece concept, the following will apply:

- The 2 pieces of baggage should have dimensions not exceeding 158 cms (length+width+height).
- For any additional baggage (except golf bag), a flat fee of EUR 150 will be charged.
- For Economy class travel, in case the weight of any piece of luggage weighs between 23 and 32 kg then a tax of EUR 50 per bag will be charged.
- In case both the 2 pieces of baggage exceed 32 kg or the baggage dimensions exceed 158 cms, two taxes of EUR 150 (Total EUR 300) will be charged per baggage.

5. The above provisions (Notes 1, 2, 3 and 4) apply for travel irrespective of whether beyond CDG sector is an Air Mauritius or Air France flight number.
6. For weight concept, provisions exist for excess baggage over and above these entitlements as follows:

a.Kestrel Flyer cardholders

- Kestrel Flyer Elite Gold
Economy Class – $20 + 12 = 32$ kg
Business Class – $30 + 12 = 42$ kg
- Kestrel Flyer Plus (Silver Card Holders)
Economy Class – $20 + 8 = 28$ kg
Business Class – $30 + 8 = 38$ kg

The above provisions (Note 6) regarding excess baggage for Kestrelflyer members are applicable on the following routes when travelling under MK code flight number only:

- Mauritius-Paris or vv.
- Mauritius-Paris-Europe*
- Europe*-Paris-Mauritius

***Applicable beyond CDG routes on which we operate with MK code and where above provisions (Note 6) apply :**

- **France**– Brest, Bordeaux, Clermont Ferrand, Lyon, Montpellier, Marseille, Mulhouse, Nice, Nantes, Pau-Pyrénées, Rennes, Strasbourg, Toulouse
- **United Kingdom**– Aberdeen, Birmingham, Bristol, Edinburgh, London Heathrow, Manchester, Newcastle
- **Spain**– Barcelona, Bilbao, Madrid, Vigo, Asturias
- **Germany**– Munich, Dusseldorf, Frankfurt
- **Austria**– Vienna
- **Italy**– Bologna, Rome, Milan
- **Switzerland**– Basel, Zurich, Geneva
