JOB PROFILE:

The Trainee Assistant Technician - Component and NDT will support authorized maintenance personnel in the assembly, inspection, troubleshooting and testing of aircraft components in accordance with Mauritian and European Aviation Part 145 Requirements. Additionally, the Trainee Assistant Technician - Component and NDT will assist in performing Non-Destructive Tests on aircraft and aircraft components.

The duties and responsibilities will include the following inter-alia:

- Assist in performing inspection/disassembly/cleaning/assembly and testing of aircraft Wheels and Brakes components.
 - Use of Test Benches
 - Use of specific tools as per approved maintenance data
- Assist in performing leakage test and functional check on Wheels and Brakes assemblies.
- Assist in performing non-destructive testing (Liquid Penetrant, Magnetic Particle, Eddy Current & Ultrasonic) on aircraft and aircraft components.
- Assist in safely storing all assigned tools/equipment to designated locations and housekeeping.
- Assist in updating documents.
- Assist in recording all work performed.
- Assist in tools inventories and periodical check/maintenance of tools/equipment.
- Assist in incoming inspections and dispatch of components to Aircraft stores.
